All horses shipped to Hawthorne Race Course whether interstate or intrastate, must be accompanied by a health certificate dated no more than 10 days prior to arrival. Health certificates and a copy of the current negative coggins test must be presented at the stable gate upon arrival or horses will not be allowed to enter the grounds. Current coggins test must be attached to foal papers when turned into the Racing Office. All horses racing in Illinois must have a negative coggins test within the past 12 months. Must have EHV vaccination within 120 days, but no sooner than 7 days.

The undersigned represents that he and all persons for he is acting have read and are familiar with the Rules of racing and regulations of the Illinois Racing Board, the race meeting conditions and Rules of Hawthorne Race Course and agrees to be bound and comply with the same, and agrees that all animals shall be subject to the same, and further agrees to be bound by the acts and decisions of the Race Officials and to all terms and conditions of any Contract with the Chicago Division of the I.T.H.A. and this application. All trainers, prior to having horses stabled at Hawthorne Race Course, must have Workmen's Compensation Insurance as required by the Illinois Racing Board.

All jockey mounts must be paid either before the horse starts or immediately after.

Absolutely no dogs or poultry allowed on the grounds!

The undersigned in consideration of the allotment of stalls does hereby waive and release any and all liability of Hawthorne Race Course for any loss, damage or injury to any personnel or horse or other personal property of the undersigned on Hawthorne's premises, except if caused by the negligence of Hawthorne or their Officers, Agents or Employees and does hereby indemnify Hawthorne for any fees, cost, or damages caused by any horse or personnel of the undersigned while on said premises.

**Ban on Horse Slaughter.** Any owners or trainers stabled at HAWTHORNE found to have directly or indirectly sold a horse for slaughter will have his or her stalls permanently revoked from HAWTHORNE. HAWTHORNE requires its horsemen to conduct due diligence on those buying horses and encourages them to support rescue and adoption efforts and to find humane ways of dealing with horses unable to continue racing.
